# Bayside Community Church Meeting March 26th 1:00 pm

**Opening Prayer:** Pastor Dustin prayed over the meeting.

Dustin said there is no quorum and that we were not voting on anything.

He went over the church reports. He offered to give copies of By-laws if anyone wanted one.

Dustin read through the 2022 Annual Meetings

Motion to accept the minutes. 1st - Julie Hickerson 2nd - Gigi Delettrez

Dustin shared about the church budget and that when we plan the budget it is reduced from the prior year.

Dustin spoke that Kitsap Transit would be sealing the parking lot and painting lines. He spoke about having three nominees for a new member of the council but the vote will be later after the church has had advance notice to know a little about the candidates.

Will vote on the nominees in a month.

# **Ron Becker: Financial Report**

Ron talks about the finances for the last year. He spoke of the financial trials of the past years - the struggles of close to bankruptcy, selling the piano, joining another church, and selling the Ed Moon building. But we made it through,

Ron spoke on the Kay Gill donation to be a fund for a scholarship. Sharenet rent is \$4000.

Kitsap transit has been covering 80% of the bill for the lawn care which is done by Quan Lawn Care. Ron spoke on the council having a goal of raising Dustin's salary to match the national average.

Ron did a comparison chart of the last 5 years of the church's total expenses, tithe income, net income.

Ron said the church is still in the black.

# Questions

It was asked about the difference in the amount for years on the financial slide and if the difference was from the income of Sharenet's rent.

Church member asked about if the missionary list had changed. Dustin spoke on the ministry giving amount being increased. Two more missionaries were added. A total of \$13,600 was given to the missions. Dustin's goal is to have the amount given to missions not coming out of the general fund but from missions funds.

A question was asked about #1310 on the budget about the electrical bill of Sharenet. Sharenet pays 50% of the bill.

A question was asked about how long the church would be paying the loan fee. A question was asked about the interest rate . Dustin mentioned it was lower than 6%.

A question on the 501C bill about tax exempt status of the church. Dustin assured the church that the Network is saying there is still robust protection for churches.
